Summit County Council\* will hold a public hearing to discuss the projects determined to be applied for in the CDBG Small Cities Program in the Program Year 2020. Project 1: Echo Mutual Water Company would like to replace its 50,000-gallon water storage tank in Echo, Utah. The tank is over 40 years old and has had several repairs to fix leaking cracks. In addition to replacing the tank, the piping that connects the tanks will be replaced. Project 2: Summit County Seniors Services would like to purchase another senior program bus with ADA capability. Due to the growing senior population in Summit County, and having a bus that is 17 years old, more transportation is needed. Comments will be solicited on each of these project's scope, implementation, and effects on residents.
