The tax amount listed shows the amount due as of January 31, 2022 if no further payments are received by that date.

Unless these delinquent amounts are paid on or before January 31, 2022, an additional 1.5% penalty will be charged to the account listed. In addition, interest will begin to accrue on February 1, 2022, calculated as of January 1, 2022.
